Others present: City Manager Judie Milner

City Manager Milner let the council know that the Makers Space Group is looking for a location and they think the High School may be a good spot for them. Milner approached the chairman of the school board and he will be presenting this option to the board as well.

Makers Space is desperate to get a location set up since they are receiving a lot of heavy equipment from Watts.

A temporary option might be the Proulx Center with a start and end date.

Milner added that it is important that Franklin allow them into the community.

There were discussions about storing the equipment in the Proulx Center temporarily and issues getting in and out of the second floor. They would also have to share space for basketball, etc. There is concern that a couple of inches of concrete may not be enough to support the heavy equipment.

Councilor Trudel asked if this had been presented to the city attorney and who would be liable.

Milner answered stating that her next step is to go over this with City Attorney Fitzgerald, but she didn't want to get everyone involved without presenting to the council first. If the council approves, she will look into this further.

It was agreed that City Manager Milner could go forward with talking with Fitzgerald and would let the council know what his recommendations are and what the next steps would be to proceed.

Motion: Councilor Dzujna moved that the Franklin City Council leave nonpublic session and return to public session. Motion seconded by Bunker.
