Dear Zoning Board Members,

On behalf of the Public Service of New Hampshire d/b/a Eversource Energy (Eversource), Stantec Consulting Services Inc. (Stantec) is requesting consideration of a height variance to conduct necessary structure replacements on Eversource's F139 transmission line in the City of Franklin. Eversource has identified 19 existing structures that require replacement along the existing F139 transmission line corridor in Franklin. These structures are part of a distribution system that serves the greater Franklin area. The proposed project involves replacing select existing wooden H-frame structures that are damaged or deteriorating with new, steel H-frame structures. In addition to the 19 structure replacements, one structure will be removed but not replaced.

Eversource requests a variance from the City of Franklin to exceed the height restrictions defined in Article III § 305-15 B of the Zoning Ordinance which limit the height of essential services transmission structures to 50 feet above ground level. The proposed replacement structures will be greater than 50 feet above ground level above; therefore, Eversource is requesting approval of a variance. Eversource's enclosed application for a variance includes the following:

In response to the Request for More Information about the above-referenced project, dated September 4, 2019, we offer the following (numbered per the RFMI):

- 1. Regarding avoidance and minimization:
 - a. The City of Franklin Site Plan approval for this project requires that access to the solar arrays be via Sanborn Street – access from other points is not permitted due to the density of the surrounding residential neighborhoods. There is a gated entry point at the end of Duffy Street as requested by the Fire Department - for emergency use only.
 - b. Driveway side slopes at the proposed wetland crossing have been steepened to 2:1.
 - c. The proposed culvert has been increased to a 24-inch diameter pipe and the riprap outlet protection has been replaced with a stone-lined plunge pool. HydroCAD output for the culvert catchment area is included with this correspondence for your reference. The proposed impacts to wetlands have been reduced to 2,110 square feet.
- 2. A full-sized plan set is provided with this correspondence which includes, as requested:
 - a. An ALTA Survey for Lots 147-51 and 147-404 which incorporates current wetland delineations stamped by the responsible Certified Wetland Scientist.
 - b. The locations of all proposed solar panels, driveways, equipment pads, and stormwater controls are shown. Please note that there is no installation of solar panels in wetland areas. Disturbance of wetlands is limited to the area requested in the permit application.


