Great Gains Forest – Timber Trespass – Glenn and Bob shared information with Commission regarding a timber trespass incident in the Great Gains Forest that occurred on or about September 10, 2018. They reported that the City Manager was made aware of the incident

Great Gains Forest – Proposed Mountain Biking Trails – Mike Geldermann and Kyle Matzke from the Central New Hampshire Chapter of the New England Mountain Biking Association (NEMBA) spoke with the Commission about the possibility installing bike trails within the Great Gains Forest. The Commission discussed prior plans to install trails in 2013. The project was abandoned due to lack on individuals available to cut the trails. Mike and Kyle indicated they do not yet have specifics on where NEMBA's proposed would be constructed. The Commission requested they flag the proposed trails, after which a walk through with the Commission would be organized.

Great Gains Forest – Proposed Snowmobile Groomer Shed – Jim Jones of the Franklin Outing Club presented preliminary plans for the construction of a Groomer Shed in the Great Gains Forest, indicating

the design work is still in progress. He also informed the Commission that he would like to start excavation of the proposed site as soon as possible despite not having all the funds necessary to complete the project. The Commission encouraged Jim to return with detailed plans at a later date.
